Notice to all Stakeholders: Annual Review of Commercial Vehicles Insurance Loss Experience

The Automobile Insurance Rate Board (AIRB) is commencing its 2016 Annual Review to analyze industry loss experience for commercial vehicles to establish the Industry Benchmarks schedule to be used in the review of insurers' commercial vehicle rate filings for basic and additional coverage, effective October 1st, 2016. The Board invites comments from interested stakeholders as part of its Annual Review and is calling for stakeholders to send a written submission to the AIRB by August 12, 2016.

Background

Prior to 2015, the Board reviewed commercial vehicle trend rates on an annual basis for internal use in the review of Commercial filings but did not post this information on our website. At its meeting of October 23rd, 2015, the Board decided to provide greater transparency by placing the approved Benchmarks Schedule and the actuarial report on the AIRB website.

On October 30th, 2015 the AIRB issued Bulletin 07-2015 to advise all commercial vehicle automobile insurers operating in Alberta that the AIRB's 2015 review of loss trend rates had been completed based on data to December 31st, 2014 and that the Commercial Vehicles Industry Benchmarks Schedule had been approved for commercial filings effective November 1st, 2015. The Schedule and the related actuarial report were posted on the AIRB website (https://airb.alberta.ca/industry-information/communications/bulletins/).

The Board at its February 26th 2016 meeting agreed to issue a letter to industry stakeholders requesting feedback on various AIRB processes that have been introduced with the new Premiums Regulation in July 2014. Included in this letter was a request for input on the AIRB's current commercial industry benchmarks schedule and process. The response from industry was clear, that it wanted the opportunity to provide input.

The Process

The AIRB's Preliminary Report (as prepared by Oliver Wyman, the AIRB's consulting Actuary) on industry experience was <u>posted on the AIRB website</u> on Monday, July 18th, 2016. Stakeholders are invited to review the report and provide a written submission to the Board for consideration in finalizing the Commercial Industry Benchmarks Schedule for filings received on or after October 1, 2016. Written submissions must be received by Friday, August 12th, 2016.

Public disclosure of all written submissions:

All written submissions will be posted to the AIRB website Monday, August 15th, 2016.
